EMERGENCY OVERVIEW: Product is a liquid with mild acrylic odor that may be harmful if inhaled or swallowed. Product may cause serious damage to eyes, allergic skin reactions and irritation to respiratory system. Avoid breathing vapors. Avoid spillage to sewers or waterways.

SECTION 4 - FIRST AID MEASURES

4.1 Description of first aid measures

INHALATION: Move subject to fresh air and keep warm. If subject is not breathing, administer artificial respiration. If breathing is difficult, have qualified personnel administer oxygen and get medical attention.

8.2 Exposure Controls

VENTILATION: Provide natural or mechanical ventilation to minimize exposure. If practical, use local mechanical exhaust ventilation at sources of air contamination.

Negative results and no chromosome-damaging effects were found with mutagenicity studies. 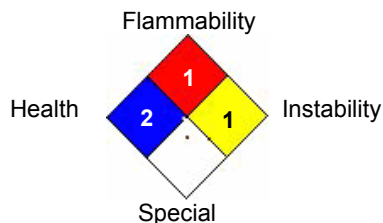
