## SECTION 4 - FIRST AID MEASURES

### 4.1 Description of first aid measures

**INHALATION:** Move subject to fresh air and keep warm. If subject is not breathing, administer artificial respiration. If breathing is difficult, have qualified personnel administer oxygen and get medical attention .

**8.2 Exposure Controls**

**VENTILATION:** Provide natural or mechanical ventilation to minimize exposure. If practical, use local mechanical exhaust ventilation at sources of air contamination.

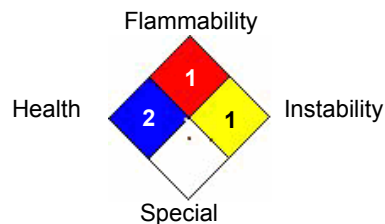
