SECTION 4 - FIRST AID MEASURES

4.1 Description of first aid measures

8.2 Exposure Controls

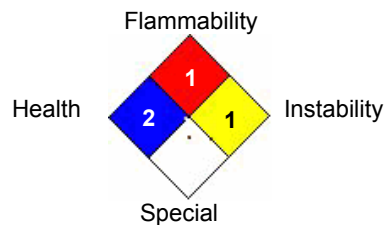
