## SECTION 4 - FIRST AID MEASURES

### 4.1 Description of first aid measures

### 8.2 Exposure Controls

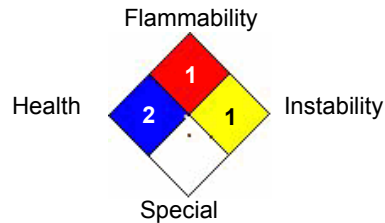
